



# Merger of two leading players creating a market leader

No. 1 consumer electronics retailer in the Czech and Slovak markets

### New logistics platform launched during the consolidation process


- New logistics hall of up to 30,000 sqm warehousing space in the Prologis Park Praha Jirny, office space ca 1,500 sqm
- State of the art semi-automated logistics system enabling delivery effectively within 24 hours from the order placement
- Associated CAPEX of up to EUR 15m
- Launched in pre-Christmas season


Structure before GPEF III entry:





#### ... merger under a holding entity...


Structure following GPEF III entry:

- 2009 Tough negotiations between HP TRONIC and Genesis over VItava.cz
- 2010 VItava.cz acquired by HP TRONIC
- 2014 First HP TRONIC/Datart deal discussions with Genesis
- 2016 (spring) Discussion with Genesis re-launched
- 2016 (summer) Datart owners approached
- 2017 (summer) Deal signed
- 2017 (autumn) Deal completed
